I further hereby swear and affirm that the information set forth in this affidavit is true and correct to the best of my knowledge and belief as of \_\_\_\_\_, \_\_\_\_\_. In the event a change occurs which would make me disqualified to volunteer, I will immediately notify North Way Christian Community of the change and will immediately resign the volunteer position. I further understand that my signature being made on this document, is subject to 18 Pa.C.S.A. § 4903 relating to crimes for false sworn statements which is a misdemeanor of the third degree punishable by up to one year imprisonment.
